## PROCESSING TIME:

THE INTERVIEW SHOULD BE SCHEDULED AT LEAST 2-3 MONTHS IN ADVANCE AS THE EMBASSY HAS LIMITED APPOINTMENTS. AFTER YOUR INTERVIEW THE U.S. PASSPORT & CERTIFICATE SHOULD BE ISSUED WITHIN 5-7 BUSINESS DAYS.

## REQUIRED DOCUMENTS FOR U.S. CITIZEN PARENT(S):

- EVIDENCE OF CITIZENSHIP
  - U.S. PASSPORT(s)
  - CITIZENSHIP CERTIFICATE
  - BIRTH CERTIFICATE
- SOCIAL SECURITY NUMBER(s)
- IDENTIFICATION DOCUMENT FOR NON-U.S. CITIZEN PARENT
- PROOF OF PHYSICAL RESIDENCE IN UNITED STATES

Five years (1,825 days) BEFORE the birth of the child, with two of those years (730 days) occurring after the age of 14.

  - PASSPORT STAMPS (*DEPARTURES & ENTRIES*)
  - SOCIAL SECURITY STATEMENT

- MATRIMONY/DIVROCE CERTIFICATE\* (IF MARRIED WHEN CHILD WAS BORN)

**\*IN THE DOMINICAN REPUBLIC, BIRTH, MARRIAGE, DIVORCE AND DEATH RECORDS ARE OBTAINED FROM THE LOCAL REGISTRY OFFICE (OFICIALIA ESTADO CIVIL) CLOSEST TO THE PLACE WHERE THE EVENT TOOK PLACE. SUCH DOCUMENTS MUST THEN BE TAKEN TO THE CENTRAL REGISTRY OFFICE (OFICINA CENTRAL DE ESTADO CIVIL) AT THE ELECTORAL COMMISSION (JUNTA CENTRAL ELECTORAL) IN SANTO DOMINGO TO BE LEGALIZED. ONLY LEGALIZED DOMINICAN CIVIL DOCUMENTS THAT ARE SIGNED, STAMPED AND SEALED ON BOTH SIDES WILL BE ACCEPTED.**
